

Edwarde Clarke of Old Basing, husbandman 1558

In the name of God Amen the eleventh day of December in the year of our Lord God 1587 I Edwarde Clarke of Basing in the county of Southampton husbandman. being sick in body but of good and perfect remembrance, thanks be given to God, do make this my last will and testament in manner and form following. **First** I bequeath my soul to Almighty God my Maker and Redeemer and my body to be buried in the churchyard of Basing aforesaid. **Item** I give to the mother church of Winchester 4d. **Item** I give to the poor men's box of the parish of Basing 12d. **Item** I give to my daughter Joane Clarke thirteen pounds six shillings and eight pence of good and lawful English money to be paid unto her when and as soon as she shall come to and accomplish the age of eighteen years. **Item** that whereas there is a certain sum of money between my brother in law Richard Blake and me by him heretofore paid and of me received, and as it was then between us both agreed, so now my last will and testament is that the said Richarde Blake shall have the use of all the rooms in the dwelling house and barn and the land which he now holds of me with all commons and commodities thereto belonging to him and his assigns for and during all the term of years yet to come by virtue of my lease thereof in respect of the money I have already received. **And he** shall stand to the walling of such rooms of the dwelling house, and the thatching of the rooms of the barn which he now holds. **I appoint** and ordain Elizabeth Clarke my wife sole executrix of this my last will and testament to whom my debts and funeral being discharged and legacies paid, I give all the rest of my goods as well moveable as unmoveable and I do appoint overseers of this my last will my well beloved friends Jhon Fixor, Jhon Clarke and George Hawtril and to each of them for their pains hereafter to be taken I give 3s 4d. **Witnesses** to this will are the parties above said. Year and day above written.

Probate granted 16 April 1588 to the executrix. Obligation to Thomas Par of Basing husbandman and Thomas Whelan of Sherfield on Loddon yeoman.
